BradenHead

Comment: The well is currently temporarily abandoned. There is no separator on the location. Bradenhead test performed. Bradenhead venting to produced water tank regulated at 50 psi. On shut in, bradenhead pressure built from 50 psi to 51 psi in 1 minute. Flow during 30 minute period observed was continuous gas with water. Operator reports well produces 8 bwpd from bradenhead.

CA: Perform an MIT or provide evidence that the well has not been temporarily abandoned more than 30 days. Comply with any applicable Colorado Department of Public Health regulations regarding venting of natural gas.
