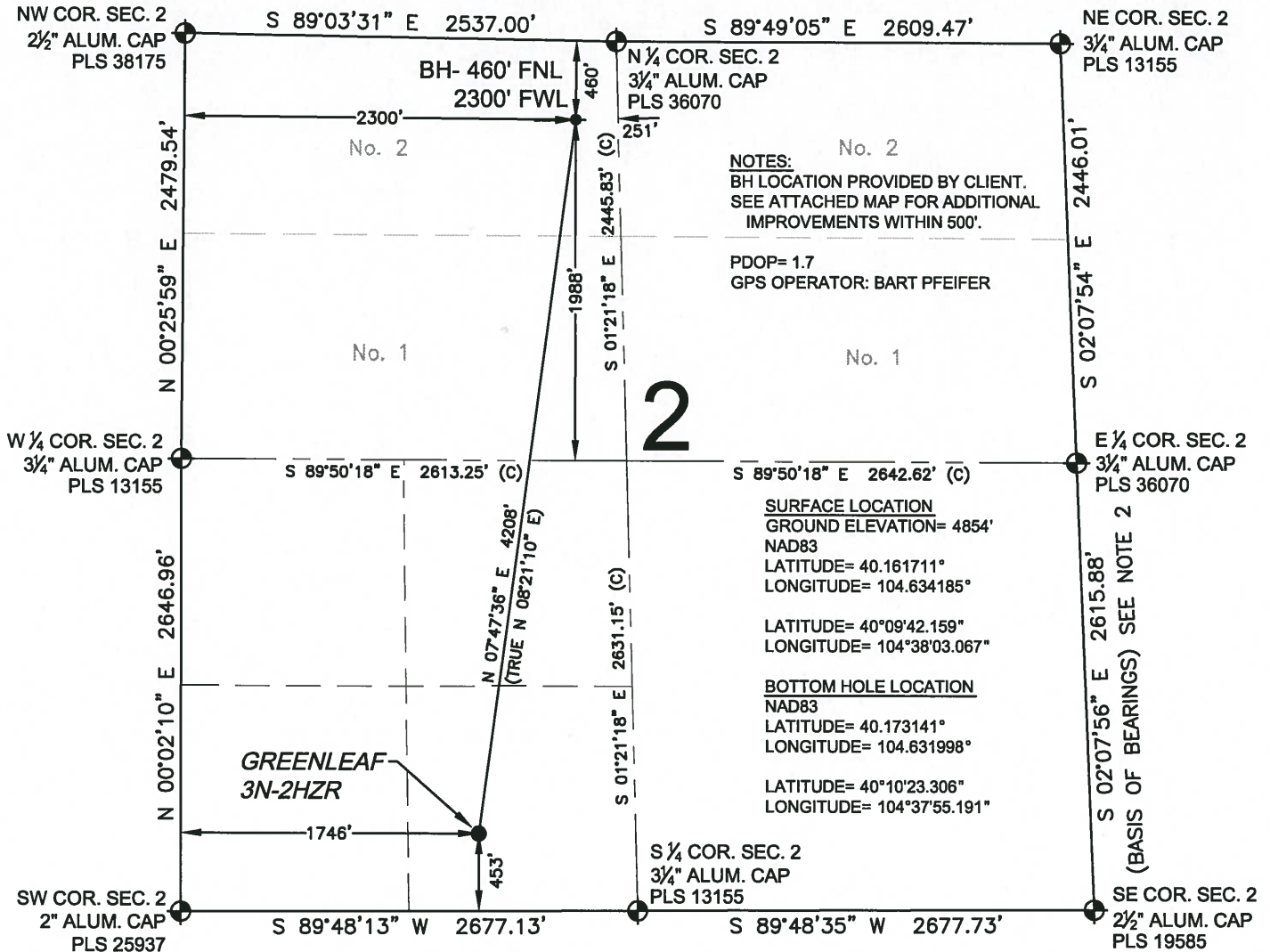


# WELL LOCATION CERTIFICATE: GREENLEAF 3N-2HZR

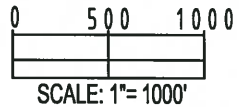

- ◆ = EXISTING WELL

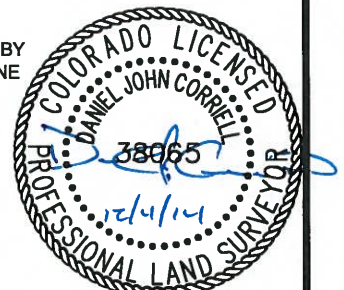

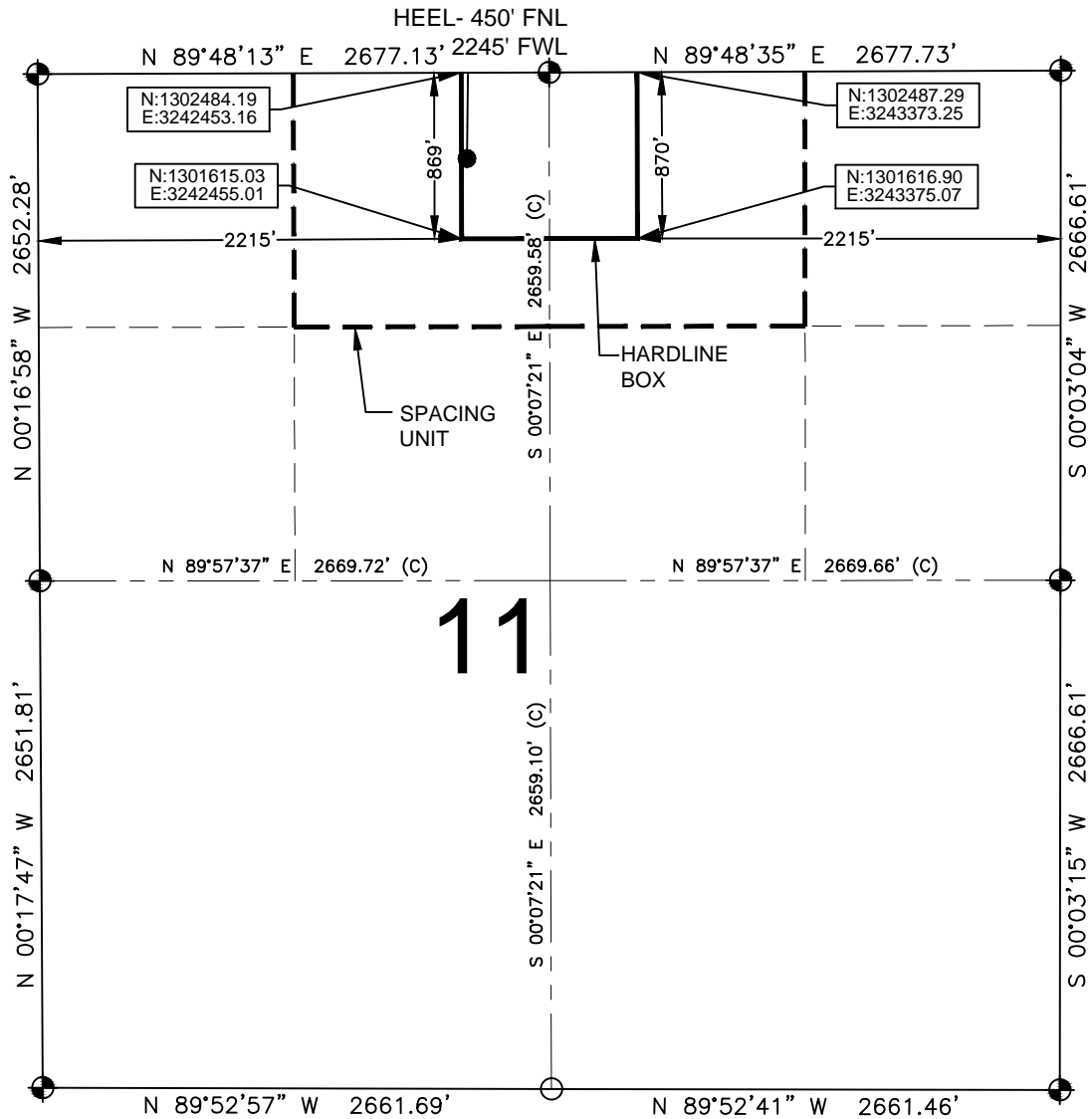

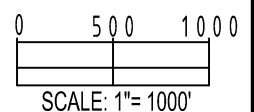
