- 4) RIH 1 1/4" tubing down annulus w/ mule shoe to approx. 1200'. Condition hole.
- 5) RU cement crew, pump 200 sx cement w/ gas check, bringing cement to surface casing shoe at approx 747'
- 6) POOH w/ 1 1/4" tubing to 797'. Reverse circulate out until no returns of cement at surface.
- 7) POOH w/ 1 1/4" tubing. Re-land casing.
- 8) SI well & WOC (at least 4 hours, but preferably overnight). Run CBL, recording new cement depths.
- 9) Clean out hole.
- 10) RDMO.
