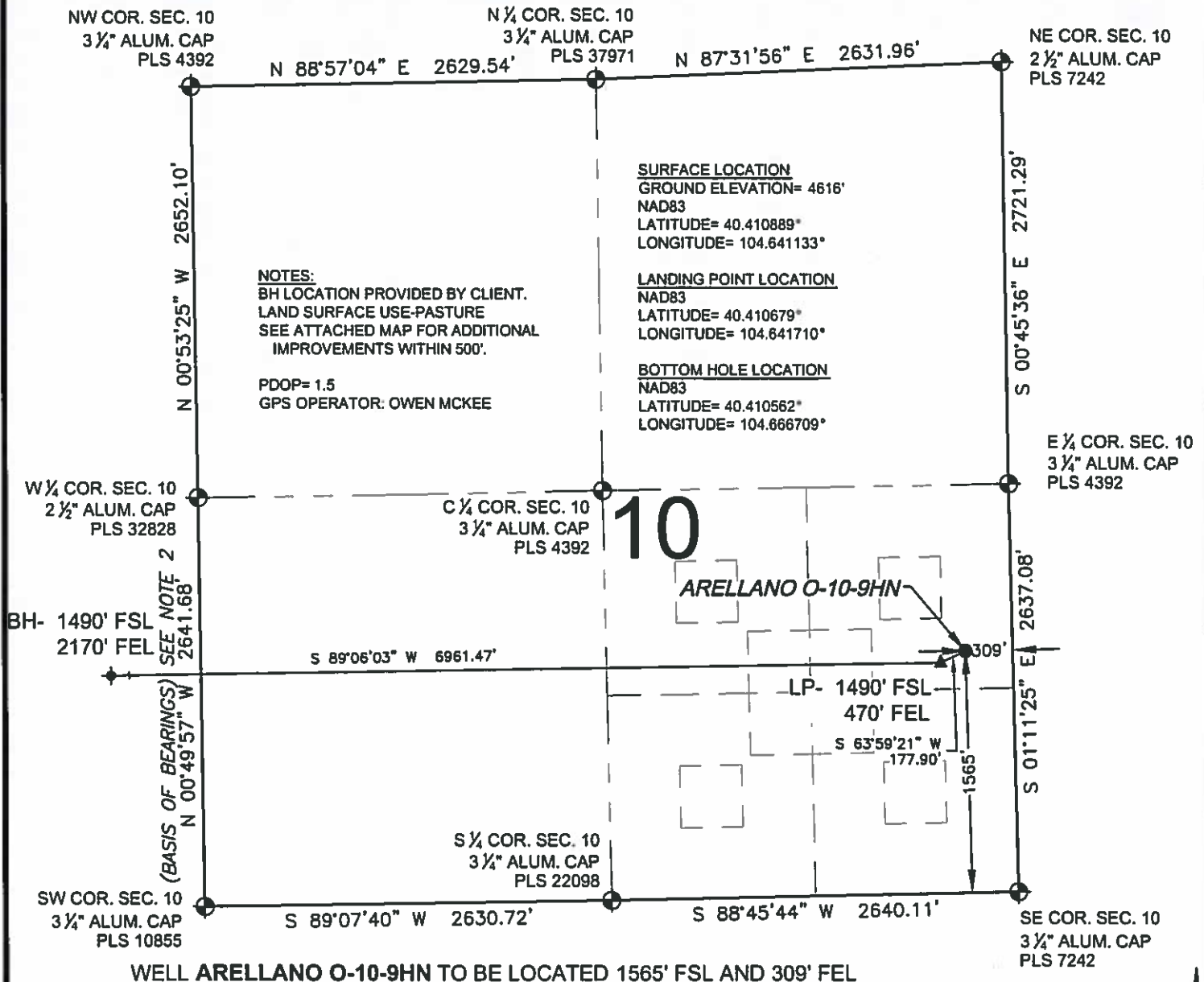


# WELL LOCATION CERTIFICATE: ARELLANO O-10-9HN

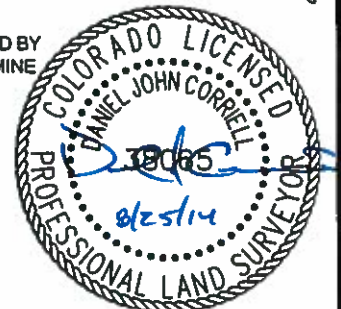

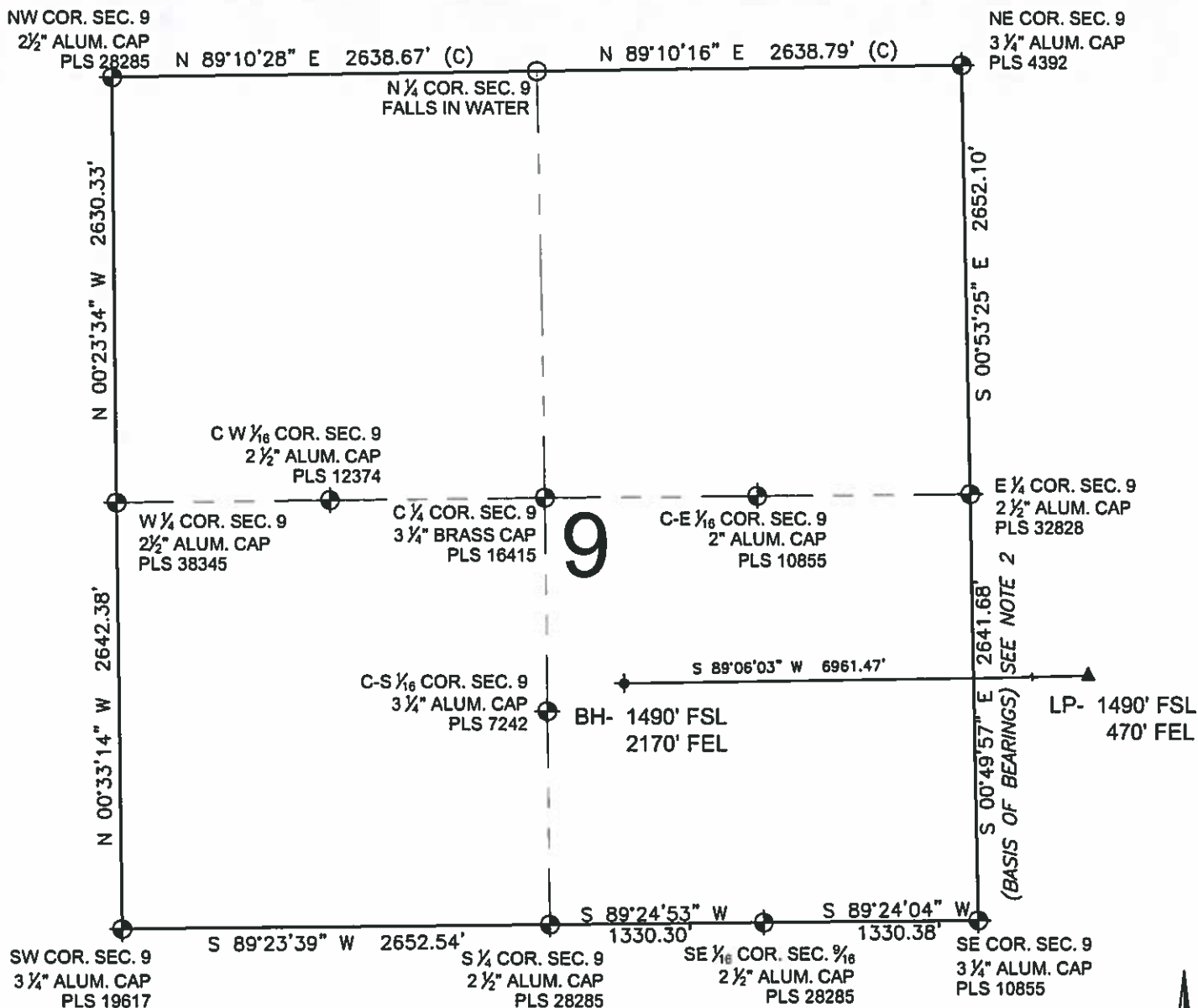
