## COMMENTS:

This submittal is in response to a request by Chris Canfield to close Incident Report Number 1941500; the Form 19 for this spill was originally submitted on December 8th, 2008, to report a filtered produced water spill to ground, and to the dry Conn Creek ephemeral drainage. After discovery and containment of the spill, Oxy completed sampling of the impacted soils in ten (10) locations, and one (1) additional water sample of the spilled produced water. Potential impacts were evaluated using these sample data from impacted soils at the source of the spill, water collected in a stormwater catchment basin, and impacted soils within the ephemeral drainage; results were compared to the COGCC Table 910-01 standards applicable at the time. It was determined that, due to the lack of flow in the applicable portion of ephemeral drainage to Conn Creek, and the low concentrations detected in the surface soils within the dry ephemeral drainage, that there would be little or no impact to surface waters. See attached spreadsheet labelled "Table 1."

In addition, Oxy has voluntarily conducted sampling of the lower sections of Conn Creek on an ongoing basis since January 2013. This portion of Conn Creek typically flows at the surface year around, is located down-gradient of Oxy operations, and provides consistent representation of normal surface water quality in the basin. A review of these analytical results indicates that Oxy has not impacted surface water quality in Conn Creek with continued development and operation of the Oxy oil and gas facilities in the area. This data is provided in the attached spreadsheet labelled "Table 2".
