The Tompkins well pad (Loc ID 438312) has been constructed and is scheduled for drilling operations beginning in September of 2015 (subject to change). Ursa would like to leave the 15 conductors in place to support our drilling schedule. 16" Conductor pipe was set on 12/09/2014 at a depth of 60' with 70 sxs.
