Diana,

We believe that January 10th is a reasonable deadline to complete the remainder of these P&As. This factors in the possibility of encountering problems on every well and the upcoming Christmas and New Years holiday schedule. So far, each well we've been on has had problems, ranging from undocumented squeeze jobs to severe wellbore integrity issues. We are doing all we can to finish these as quickly as possible while performing a quality cement job.

Please let us know if this date is acceptable. The sooner we know, the more prepared we can be to finish these up.

Good Afternoon Stuart,

Extraction Oil & Gas is currently in the process of plugging all six of the wells listed as “out of compliance” in the attached letter dated September 22nd, 2014. These wells were recently acquired by Extraction from Sundance Energy, after this letter was issued. We have submitted Form 6s for each well, all of which have been approved.

The intended timeline of these six abandonment procedures has changed, due to unexpected complications with the first P&A. Though we plan on commissioning another rig to help us finish up the remainder of the P&As, our level of confidence that we can plug all six wells before the deadline is low. We would like to request an extension to this deadline. At your earliest convenience, please let us know if this is at all possible.
