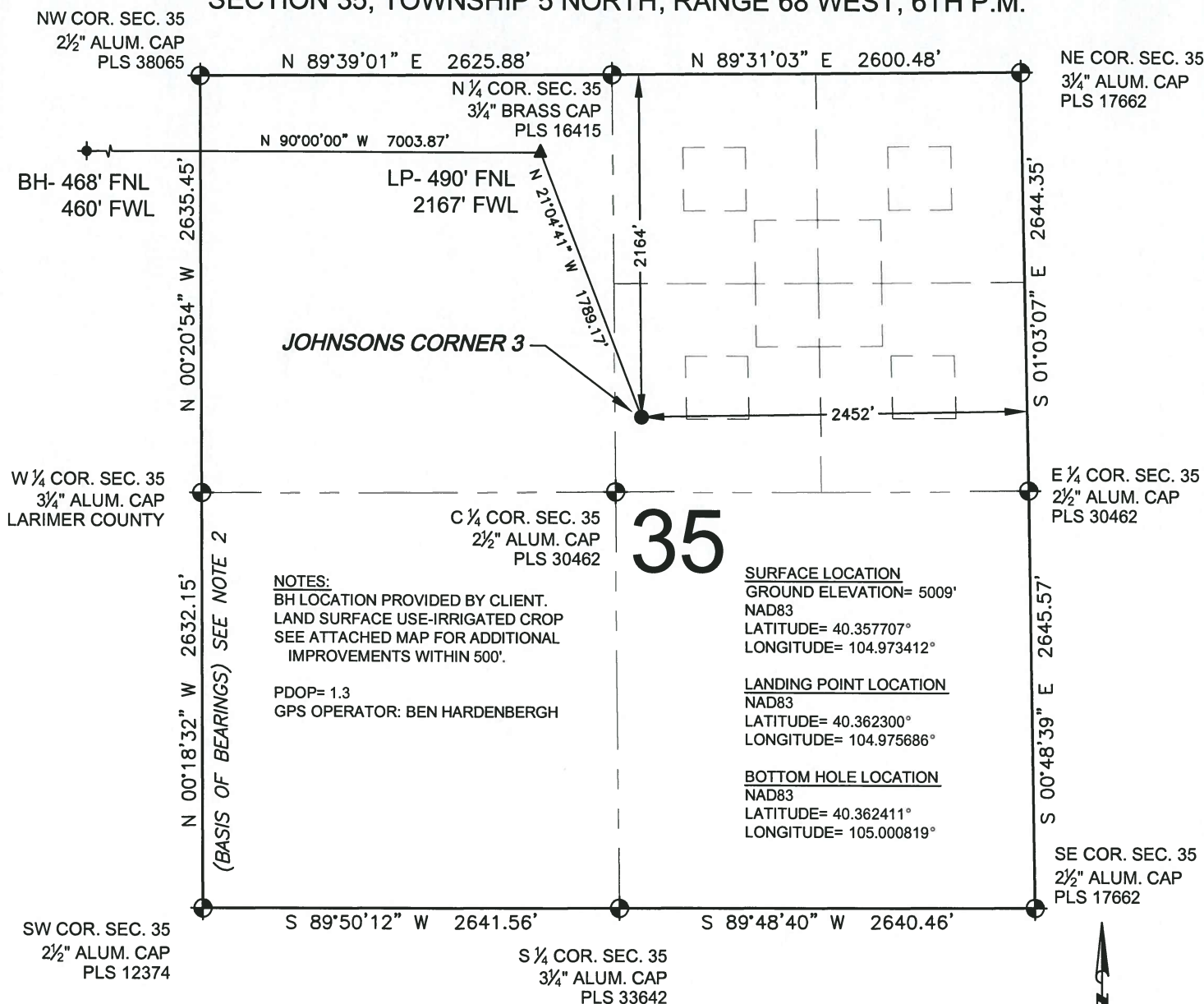


WELL LOCATION CERTIFICATE: JOHNSONS CORNER 3

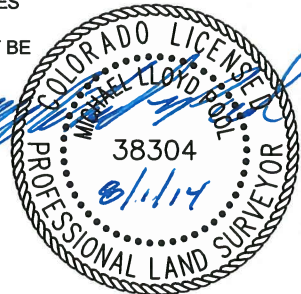
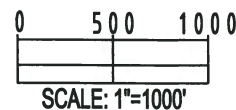

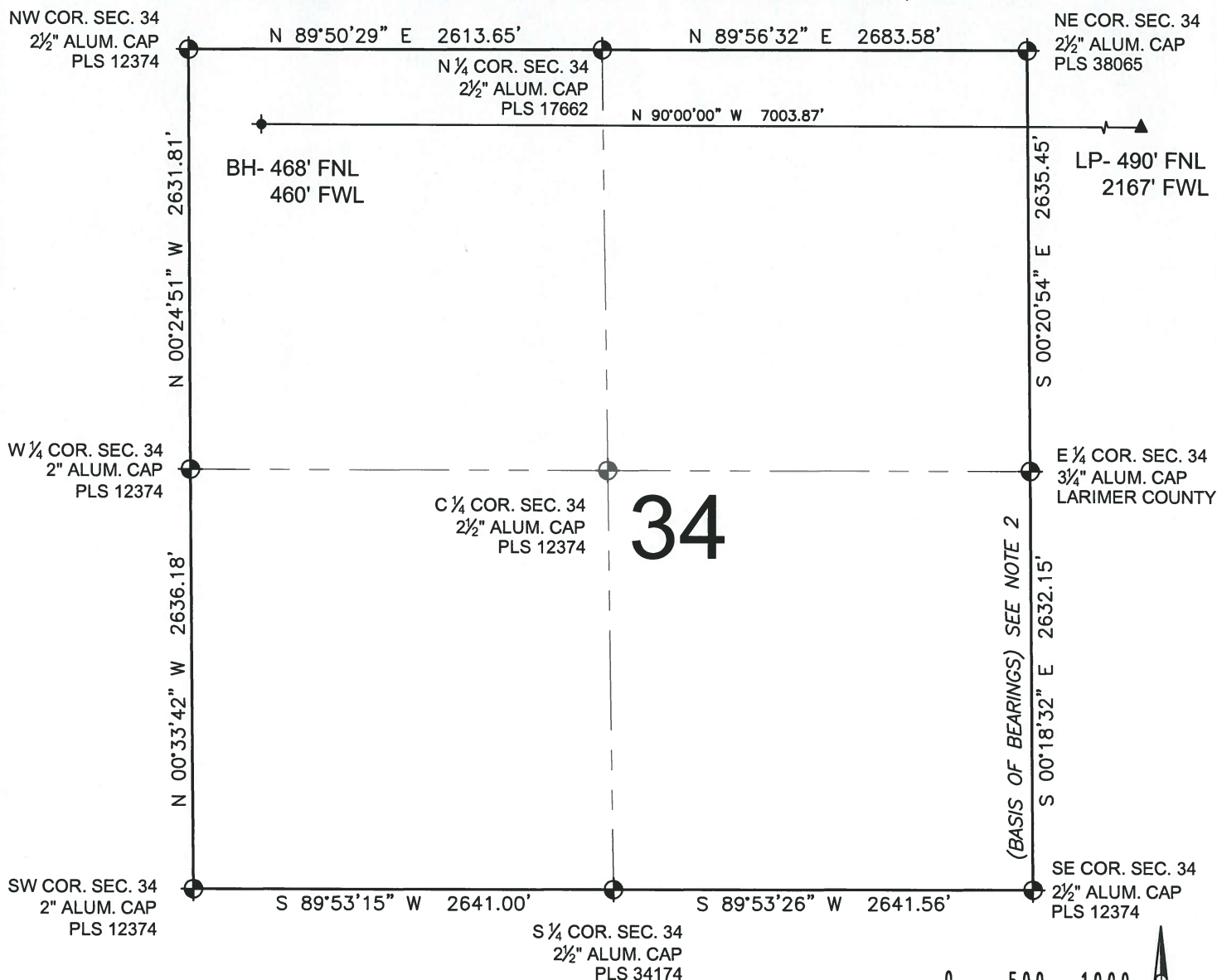
