Comments:

Based on Kerr-McGee Oil and Gas Onshore, LP. (Kerr-McGee) survey method, interim reclamation as defined in regulation 1003.e. (2) has been met at the above referenced location. Kerr-McGee's survey method consisted of randomly selecting 20 survey points on the well pad and 20 survey points within a reference area representative of the pre-disturbance vegetative levels. The area reclaimed on the well pad has been seeded with Dahurian Wildrye, VNS (24.49%), Intermediate Wheatgrass, Rush (19.03%), Orchardgrass, Profile (18.97%), Forage per. Ryegrass, Albion (18.74 %), and Smooth Brome, VNS (14.07%) and surpasses the required 80 percent of the pre-disturbance vegetation growth excluding noxious weeds. Four photographs were taken facing each cardinal direction. A fifth photograph was taken to document the total cover of live perennial vegetation of the site. A sixth photograph was taken to document the representative total coverage of the adjacent or nearby undisturbed land.
