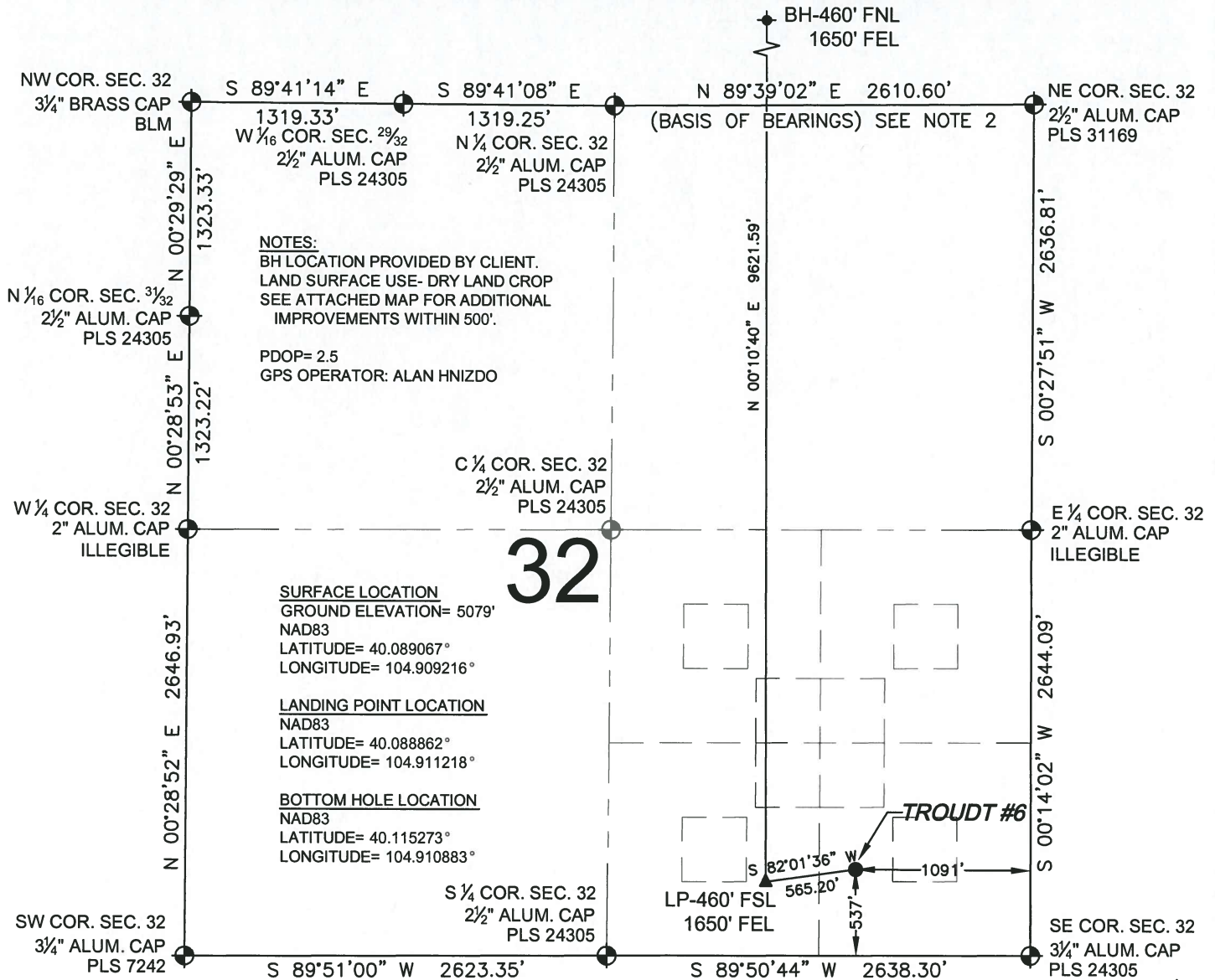


WELL LOCATION CERTIFICATE: TROUDT #6

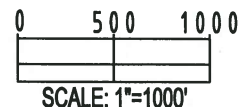

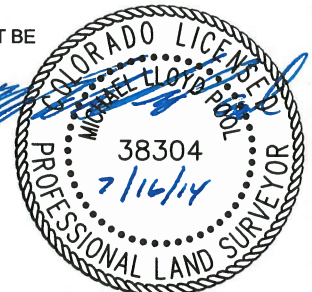

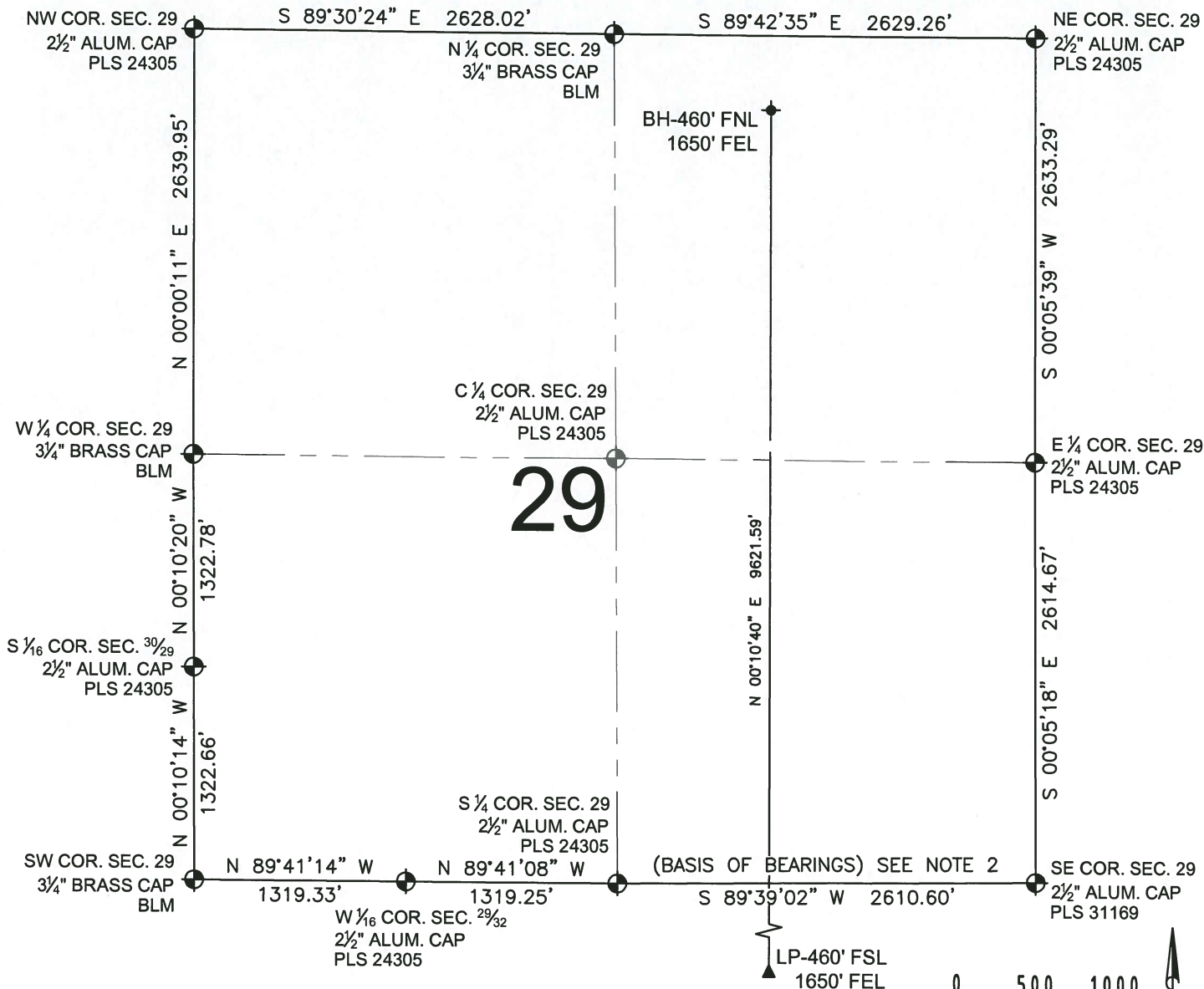
