Interim Reclamation was performed by the previous operator prior to the acquisition of the location by Bayswater. The reclamation start date is approximately 3 months after the spud date due to lack of records by the previous operator. Bayswater is in the process of maintaining the location to meet Rule 1003.e. requirements. Once vegetative cover and weed control requirements are met, a Form 4 Sundry Notice will be submitted to COGCC documenting the completion of Interim Reclamation.
