Red River Ranch Holdings LLC (RRR) is both the owner and operator of Red River Ranch. RRR has plugged Well RRR 14-1 R68W and has submitted a Form 6 Subsequent Report, which is currently under review by COGCC. In this Form 4, RRR is seeking COGCC approval of a variance exempting it from the requirements of Rule 1004.a that all debris and surface equipment be removed within 3 months of plugging a well and that other identified reclamation activities be completed within 12 months. Snow and cold weather limit access to the site as well as revegetation until late spring. RRR anticipates being able to initiate activities required by Rule 1004.a by 6/1/2015.
