All appropriate treatment will occur after internal inspection of the location and identification of the weeds in question.

Additionally, Encana states that the location ***IS MONITORED FOR WEEDS ON LOCATION**** and will continue to take appropriate action to control noxious weeds in compliance with COGCC rules and the Colorado Noxious Weed Act.

With respect to the berm capacity, Encana field representatives checked the dimensions of both the tank and berm in question and determined that the capacity was adequate.
