Red River Ranch Holdings LLC (RRR) is both the owner and operator of Red River Ranch. RRR has plugged Well RRR 18-5 R68W and has submitted a Form 6 Subsequent Report, which is currently under review by COGCC. In this Form 4, RRR is seeking COGCC approval of a variance exempting it from the Rule 1004.a requirements to remove all debris and surface equipment within 3 months of plugging and to complete certain other reclamation activities within 12 months, because snow and cold weather limit access and revegetation until late spring. RRR anticipates being able to initiate activities required by Rule 1004.a by 6/2/2015.
