This sundry is being submitted per to bring this well into compliance with requirements of the Notice to Operators - Procedures for Setting Conductor Pipe as the well will not be drilled within 30 days of conductor pipe being set. On 3/11/14 - 16" Conductor pipe was set in a 24" hole at a depth of 75' with 111 sxs. The Monument Ridge well pad (Loc ID 422286) is scheduled for drilling operations beginning in June, 2016 (subject to change). Ursa would like to leave the 4 conductors in place to support our drilling schedule.
