Doug,

Please find attached the operator certification letter stating the outcome of the meeting held on January 10th. I have also included Jamison's notes regarding the meeting.

"I met with the Sondrup, Helzer, and the Hoff families on Saturday, 10 January at 2:00 p.m. All three families have properties adjacent to the Westwind 7-P Pad. The families wanted to know about timing of drilling which I explained would not occur in 2015, but possibly in 2016. They also wanted to know about the wellhead and facility layout which I showed them, and they were relieved to have the facility located on the eastern end of the property further away from their homes.

Their main concern centered around the access point off of CR-1 (Larimer County) and CR-13 (Weld County) one in the same county road not being wide enough to accommodate truck traffic turning off of the road into location. I told them that we would work with the current Surface Owners, the Koldeways, and the county in order to come up with a safe solution. All 3 families indicated that they would be talking to Weld County to voice their concerns with the access point with regards to the width."
