Once the drilling and completion rigs leave the site, there will be no permanently installed lighting on site. Lighting shall be mounted at compressor statins on a pole or building and directed downward to illuminate key areas within the facility, while minimizing the amount of light projected outside the facility. • Maintain appearance with garbage clean-up- a trash bin will be located on site to accumulate waste by the personnel drilling the wells. Site will have unused equipment, trash and junk removed immediately.
2 Traffic control	<ul style="list-style-type: none"> • Access Roads: The access road will be constructed to accommodate local emergency vehicles. The road will be maintained for access at all times. Traffic will be routed to minimize local interruption.
3 General Housekeeping	<ul style="list-style-type: none"> • The site will be cleaned of all trash and waste as soon as practical. • All Waste will be stored in sealed containers until it can be disposed of appropriately. • Solid waste will be removed from the site and disposed of per state regulations for solid waste.
4 General Housekeeping	<ul style="list-style-type: none"> • Removal of trash: All trash, debris and materials not intrinsic to the operations of the oil and gas facility shall be removed and legally disposed of as applicable. • Fencing: A meeting with the surface owner will determine a fencing plan.

This ECD shall have an adequate capacity for 1.5 times the largest flowback within a 10 mile radius, will be flanged to route gas to other or permanent oxidizing equipment and shall be provided with the equipment needed to maintain combustions where non-combustible gases are present.
