COMMENTS:

As per Kerr-McGee Oil & Gas Onshore LP's (Kerr-McGee) approved Waste Management Plan for Land Application of Water-Based Bentonitic Drilling Fluids & Associated Drill Cuttings, the drill cuttings from the Reigle 29C-9HZ well were land applied to the surface of the Reigle 29C-9HZ well pad. The drill cuttings from the well were mixed with EcoSponge bioremediation product and incorporated into the native soil during well pad reclamation activities. After final incorporation, a four point composite soil sample (Reigle 4-4 On Pad) was collected from 0-8 inches below ground surface (bgs) from the reclaimed well pad and submitted for laboratory analysis of total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and total xylenes (BTEX), pH, electrical conductivity (EC), sodium adsorption ratio (SAR), total arsenic, total barium, and arsenic by toxicity characteristic leaching procedure (TCLP). Four background soil samples (Reigle 4-4 Off (OA) through Reigle 4-4 Off (OD)) were collected from the undisturbed surface soil surrounding the well pad and submitted for laboratory analysis of total arsenic. The four background samples were also composited into one additional soil sample (Reigle 4-4 Off Comp) and submitted for laboratory analysis of pH, EC, SAR, total arsenic, and total barium. Laboratory results confirm that all concentrations and levels in sample Reigle 4-4 On Pad were within or below the Colorado Oil and Gas Conservation Commission (COGCC) allowable levels with the exception of total arsenic. The total arsenic concentration of 3.21 milligrams per kilogram (mg/kg) detected in confirmation sample Reigle 4-4 On Pad exceeded the site background concentration of 2.88 mg/kg and the COGCC allowable level of 0.39 mg/kg. However, the total arsenic concentration detected in Reigle 4-4 On Pad is below the United States Geological Survey (USGS) total arsenic background concentration of 7.72 mg/kg for the Valent-Julesberg soil association presented to the COGCC in Kerr-McGee's "Request for Arsenic Sampling Determination Pursuant to Table 910-1, Footnote 1". In addition, the TCLP arsenic concentration was below the laboratory reporting limit of 0.300 mg/L. Based on the laboratory results, Kerr-McGee is requesting a no further action (NFA) status for the well pad. The laboratory report is included as an attachment to this Form 4.
