The subject well is the only well producing in Section 25 of 1S-60W. The well lies within the terms of a USX Exploration agreement dated 11-15-2005 as well as the lease language. The initial permit allocated 320 acres in the S/2 for the spacing unit. A Sundry was filed to change the spacing unit to 40 acres. Per the terms of the Exploration agreement and the lease (copy attached), Noble requests the spacing unit configuration be changed back to 320 acres in the S/2 of 1S-60W-25 for the J Sand. Please note, Royalty owners will not be affected by the requested change.
