

**Re: Colorado Oil and Gas Commission (COGCC) Rule 305.a.(2). Pre-application Notice and Request for a Waiver of 30 Day Notice**

Mr. Haake:

Pursuant to COGCC Rule 305.a.(2), for Oil and Gas Locations proposed within an Urban Mitigation Area or within the Buffer Zone Setback, an Operator shall provide a "Notice of Intent to Conduct Oil and Gas Operations" to the persons specified therein not less than thirty (30) days prior to submitting a Form 2A Oil and Gas Location Assessment to the Director. K.P. Kauffman Company, Inc. (KPK) records, based on the tax assessor records of Weld County, Colorado, indicate that you are the surface owner of the lands located in the NE/4SE/4 Section 4, Township 1 North, Range 67 West, 6<sup>th</sup> PM, Weld County, Colorado. Please consider this letter notice that KPK has surveyed and will modify the following location adjacent to your property in the NE/4SE/4 Section 4, Township 1 North, Range 67 West, 6<sup>th</sup> P.M., Weld County, Colorado:

**Facility #5 (Tank Battery Location)**

KPK will be installing 5 Emission Control Units (ECD) on the tank battery location. Pursuant to the notice provided for herein, KPK respectfully requests that you waive the thirty (30) day notice requirement pursuant to Rule 305.a.(2). Your waiver of the 30 day notice does not waive your right to comment on KPK's Form 2A application; you will have the opportunity to provide comments as soon as KPK tenders the application to the COGCC, which will be available on the COGCC website shortly thereafter. Should the 30 day notice not be waived, KPK will be unable to file the application until 30 days following receipt of this letter by you. Please find below the relevant information regarding KPK's Form 2A application.
