#### COMMENTS:

Bill Barrett Corp. is submitting this sundry because a hole in the 4 ½ inch production liner was discovered after the two frac stages. BBC plans to cut and pull the liner and run external casing patch, the 4 ½ production liner would now extend all the way to surface. The rest of the casing and cement plans have not changed. Please see procedure below:

1. Clean out well with coil tubing to top of stage 2.
2. Set pump out plug with coil tubing above stage 2.
3. Run bond log on wireline to as low as we can get in the curve section ~5,800 feet.
4. With work over rig, hunt holes with a packer.
5. Burn over liner hanger and 4 ½ down below the holes in the casing.
6. Overshot or spear to pick up liner hanger.
7. Chemical cut below holes in casing.
8. Pull 4 ½ casing and liner hanger out of hole.
9. Use Weatherford external patch to run 4 ½ to surface.
