Following removal of the pit liner, below-liner soil was visually assessed with no noted staining or discoloration. Five discreet grab samples were collected from the pit bottom and walls, and were analyzed for COGCC Table 910-1 constituents of concern. Based on lab results there is no evidence of a liner failure. See attached summary table and laboratory report. If the information provided here is adequate, please close the remediation project (8604) and pit facility (414394).
