Noble requests an exception to Rule 318.A.f. for the Reliance E23-63HC well pad. Post cards requesting access to sample 23 qualifying water wells within quarter sections within a 1/2 mile of this location were mailed to landowner(s) on 11/4/2014. To date Noble has only received access to sample water well(s) 9066403, 0511148, 9066044, 0090684. At the time of sampling on 11/4/2014, It was determined that water wells 9066403 and 0511148 were abandoned. Water wells 9066044 and 0090684 were not able to be sampled due to insufficient purge volumes. The first well on the pad (Reliance E23-64-1HNA) is set to be spud on 1/27/15. If we receive approval for any water wells we will sample and submit the results.
