Temp Logs have been submitted via Form 4 Sundry (Doc # 400770256 - approved 1/13/15). Ursa received approval from COGCC Engineer, Jay Krabacher, on 1/13/15, to defer running the CBL on the subject well per Mamm Creek NTO policy. Ursa plans for an eight stage completion to TOG.
