Dear English Farms, Inc.,

Kerr-McGee Oil & Gas Onshore LP plans to drill the listed oil and gas wells from surface locations in Township 1 North, Range 65 West, Section 8 & 9.

Rule 318A of the Colorado Oil and Gas Commission's Rules and Regulations requires that wells be drilled in a square with sides four hundred (400) feet in length, the center of which is the center of any quarter/quarter, or a square with sides eight hundred (800) feet in length, the center of which is the center of any quarter. Rule 318A of the Colorado Oil and Gas Commission's Rules and Regulations also requires any new twinned well be located 50' or less from an existing oil and gas well. We will drill the wells at the above described locations, but we will need this waiver as these locations are more than 50' from the existing well and falls outside the legal drilling window.
