Requesting approval to run CBL and verify cement coverage down to 670 ft (50 ft below deepest water well) and if none exists then perform an annular fill down the annulus via 1 1/4" tubing. Will attempt to cover Upper Pierre with end of tubing at 1260 ft and 200 sx Class G 1.15 cu ft/sx. Verify w/ CBL and submit required documentation to COGCC. 8 5/8" 24# surface casing is at 254 ft. Production csg is 4.5" 11.6#.
