COMMENTS:

Three pits which had not received COGCC facility numbers were permitted retroactively on this location to support the Form 27 closure process. It appears that one of the identified pits was done so through incorrect analysis of aerial imagery and confusion over definition. The third pit was an above-ground stockpile which was disposed offsite at an approved facility. This error was carried forward through the Form 27 process, and resulted in issuance of a remediation project number (Rem 7745). In order to correct these errors, this form is being submitted with a request to abandon the original pit permit and close the associated remediation project. The two confirmed pits on this location will be addressed in separate submittals.
