In response to Inspection No. 675201050, Encana Oil and Gas (USA) Inc. has reviewed the corrective action: "generator, fuel, tanks, - remove if not needed for production of well" for LOCATION ID #312679. Encana Oil and Gas (USA) Inc. is currently conducting a production evaluation of the well associated with this location & equipment, Orchard 16-12 (L16) API #05-077-08775, and requests that the generator remain onsite until the production evaluation has been completed. Per the conclusion of the evaluation, if production is deemed economical, the generator will be re-assembled to the well in order to support production operations. If production is not deemed economical, the well will be considered for plug & abandonment, and Encana Oil and Gas (USA) Inc. will prepare the site for P&A operations and removed all unnecessary equipment.
