

**REINSTATEMENT AND FIFTH AMENDMENT
OF SURFACE USE AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, under the date of October 28, 2003, ExxonMobil Oil Corporation and Exxon Mobil Corporation (collectively, "Surface Owner") and Williams Production RMT Company did execute a Surface Use Agreement, which is recorded at Reception #643002, Book 1546, Page 742 in the official records of the State and County named above; and,

WHEREAS, under the date January 27, 2004, Surface Owner and Williams Production RMT Company did execute an Amendment of Surface Use Agreement, which is recorded at Reception #646199, Book 1559, Page 731 in the official records of the State and County named above; and,

WHEREAS, under the date February 24, 2005, Surface Owner and Williams Production RMT Company did execute a Second Amendment of Surface Use Agreement, which is recorded at Reception #670534, Book 1671, Page 468 in the official records of the State and County named above; and,

WHEREAS, under the date October 27, 2005, Surface Owner and Williams Production RMT Company did execute a Third Amendment of Surface Use Agreement, which is recorded at Reception #688246, Book 1754, Page 428 in the official records of the State and County named above; and,

WHEREAS, under the date October 24, 2006, Surface Owner and Williams Production RMT Company did execute a Fourth Amendment of Surface Use Agreement, which is recorded at Reception #714443, Book 1879, Page 899 in the official records of the State and County named above; and,

WHEREAS, said Surface Use Agreement, as amended by the above described amendments shall hereinafter be referred to as the "Agreement"; and,

WHEREAS, Williams Production RMT Company became Williams Production RMT Company LLC as set forth in the document recorded at Reception #793098 in the official records of the State and County named above; and,

WHEREAS, Williams Production RMT Company LLC is now known as WPX Energy Rocky Mountain, LLC, as set forth in a document recorded at Reception #814004 in the official records of the State and County named above ("Operator", Surface Owner and Operator being hereinafter referred to as "Parties"); and,

NOW, THEREFORE, in consideration of the premises stated herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Parties hereto, it is agreed:

The Parties agree that Paragraph 1 of the Agreement is amended to read as follows:

1. Operator may begin operations to drill the Wells any time prior to December 31, 2019, or any time thereafter as mutually agreed to by Surface Owner and Operator.

The Parties further agree that the Agreement is amended with the insertion of the attached amended Exhibit "C".

All other terms and conditions of the Agreement shall remain unaltered and shall be in full force and effect as of the date hereof.

This Reinstatement and Fifth Amendment of Surface Use Agreement shall be binding on any and all successors and assigns of the Parties.

The Parties hereto have executed this Reinstatement and Fifth Amendment of Surface Use Agreement this 27th day of August, 2014.

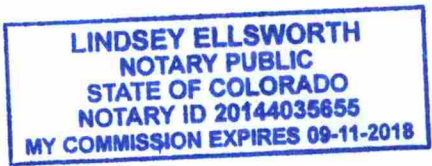
