In response to Inspection No. 675201057, Encana Oil and Gas (USA) Inc. will address the rutted and eroded road present on LOCATION ID #334316 as soon as practicable after the spring 2015 thaw and run-off. Specifically, after spring run-off and the road surfaces dry, Encana will use general blading on the road to eliminate ruts and reshape road surface. Any existing water bars and wing-ditches will be maintained as well during this time. Additionally, Encana will inspect the location and make necessary improvements to the existing surface BMP's currently in use on the location.

As requested in the inspection, Encana is submitting site-specific BMP's that are appropriate for this location given its geographical considerations.
