Comments Distance to nearest well completed in the same formation /permitted or existing well penetrating objective formation was measured to the producing Puckett 21A-1 (API# 045-19726). The distance to lease line was measured from the BHL to the north west corner of Section 1 and of the Puckett 5,141 acre lease. Please see the BMPs attached to the Form 2A Location Assessment for this well pad (Doc # 400717071). DISPOSAL PLAN: Solids control equipment consisting of shale shakers, centrifuges, and flocculating unit will be utilized to separate drill cutting solids from liquid (water). If cuttings meet Table 910-1 standards, they will be treated as soil, stockpiled on location and beneficially re-used on location or at another location as approved by COGCC Sundry Form 4. Any excess cutting will be transported to an authorized waste facility. Closed loop system will be used to separate solids from liquid. Dry cuttings will be stockpiled on location or transported off-site to an approved facility. Clean drilling fluids will be recycled and used in drilling operations at the next pad location.
