Noble Energy certifies that there are no other changes to the permitted well, other than the BHL, the top of production, and the total depth of the well. The Lease, Spacing, and Pooling information, and SHL will not change. Although the distance changed, the nearest well is unchanged from the original permit: Colt A13-645 (API: 123-40910).
