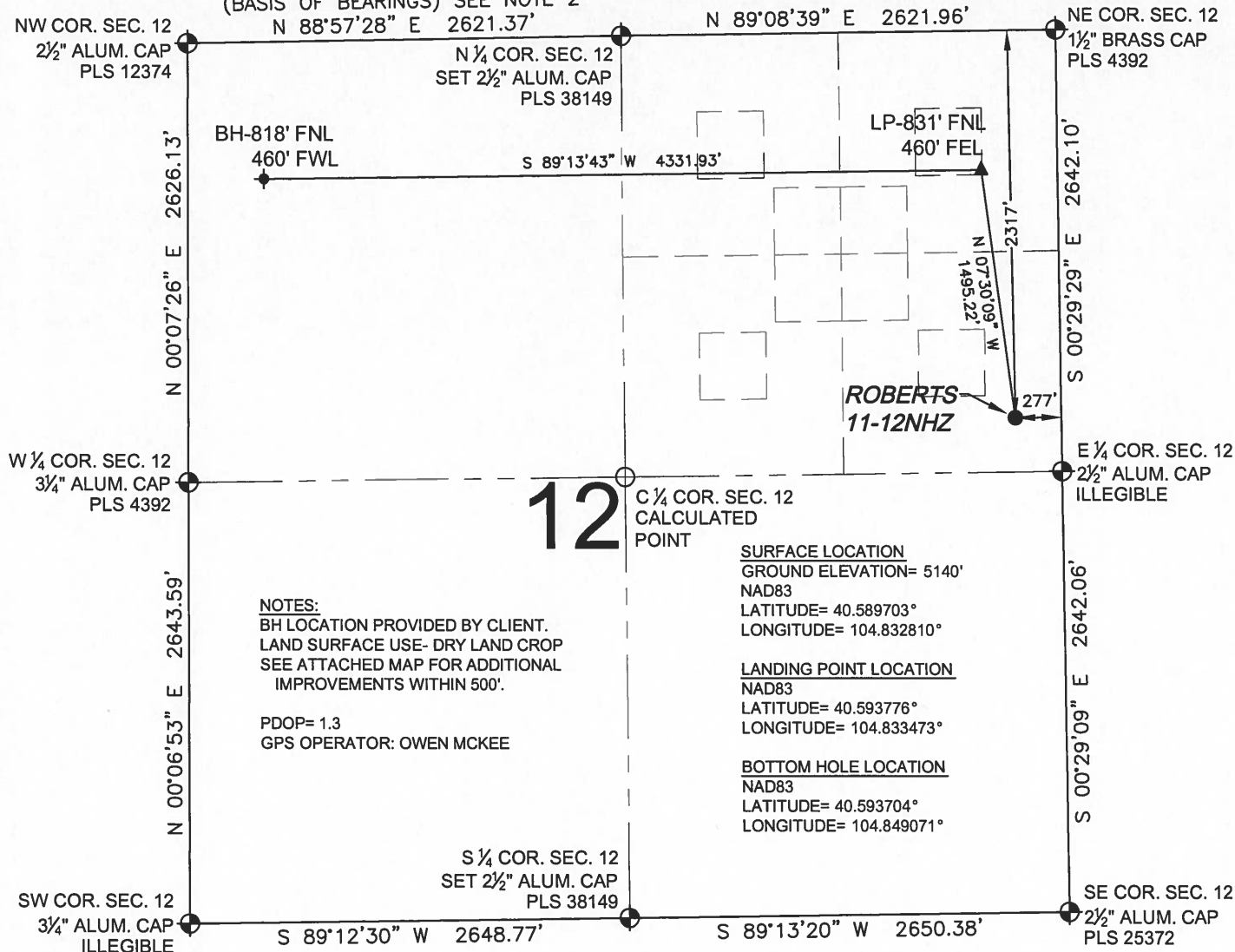


WELL LOCATION CERTIFICATE: ROBERTS 11-12NHZ

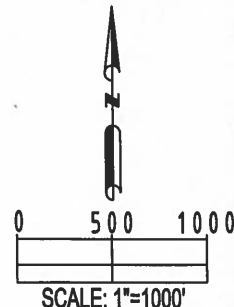
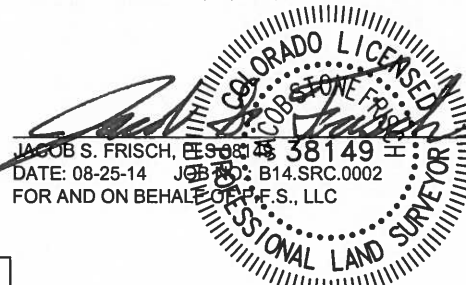
