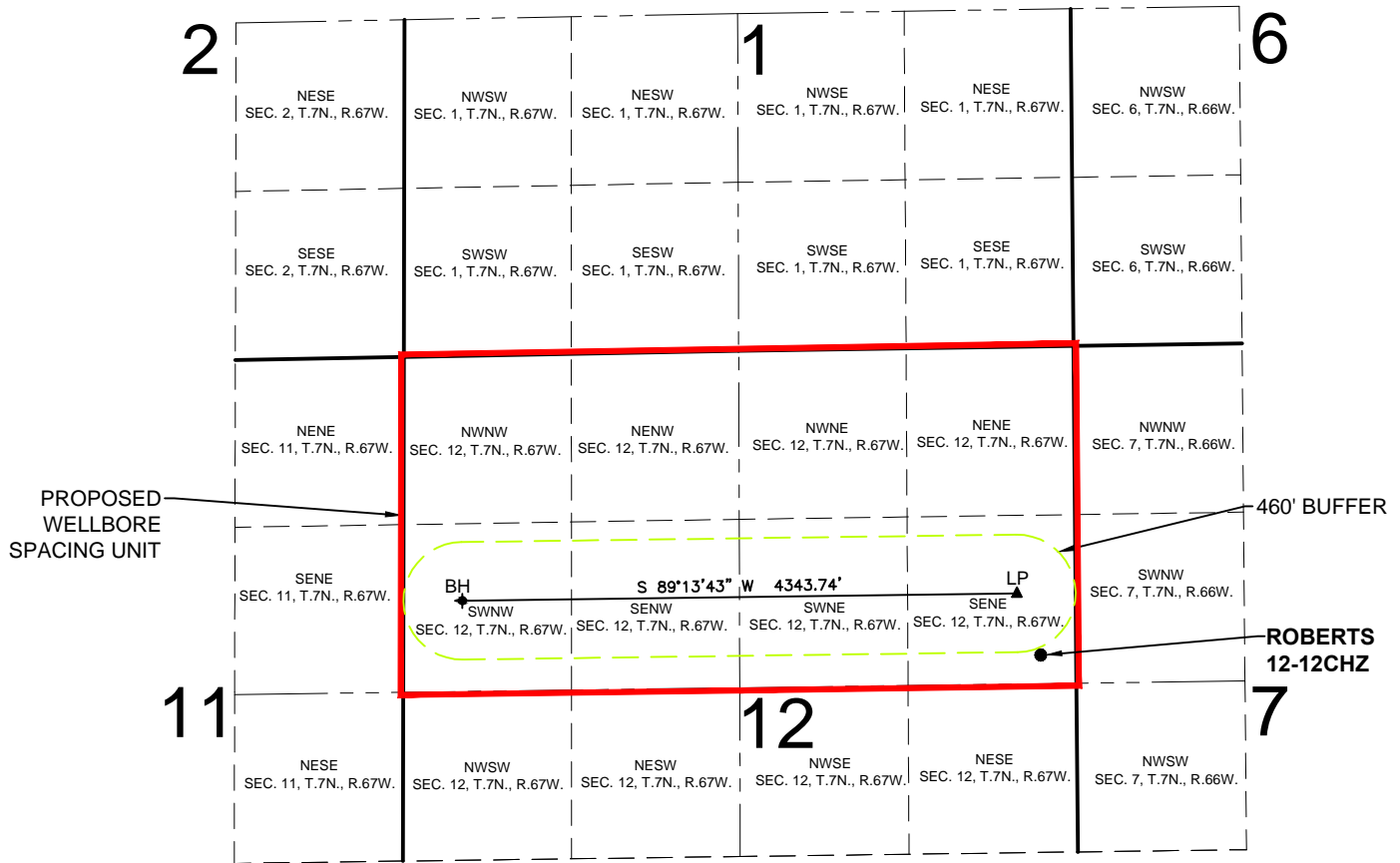

SURFACE LOCATION

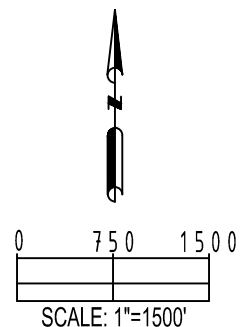
