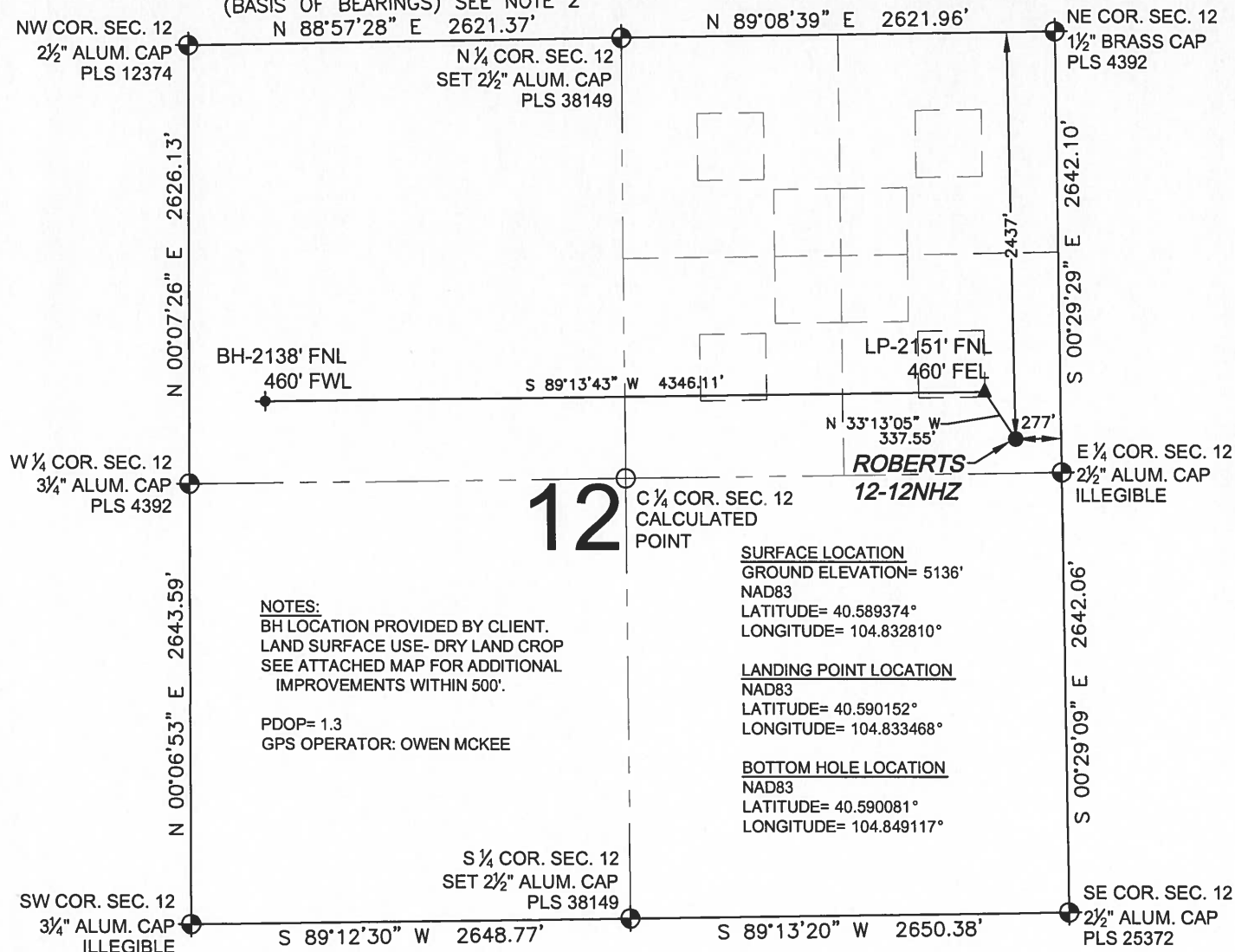


# WELL LOCATION CERTIFICATE: ROBERTS 12-12NHZ

- ◆ = EXISTING WELL

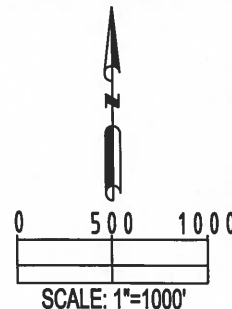
WELL ROBERTS 12-12NHZ TO BE LOCATED 2437' FNL AND 277' FEL
