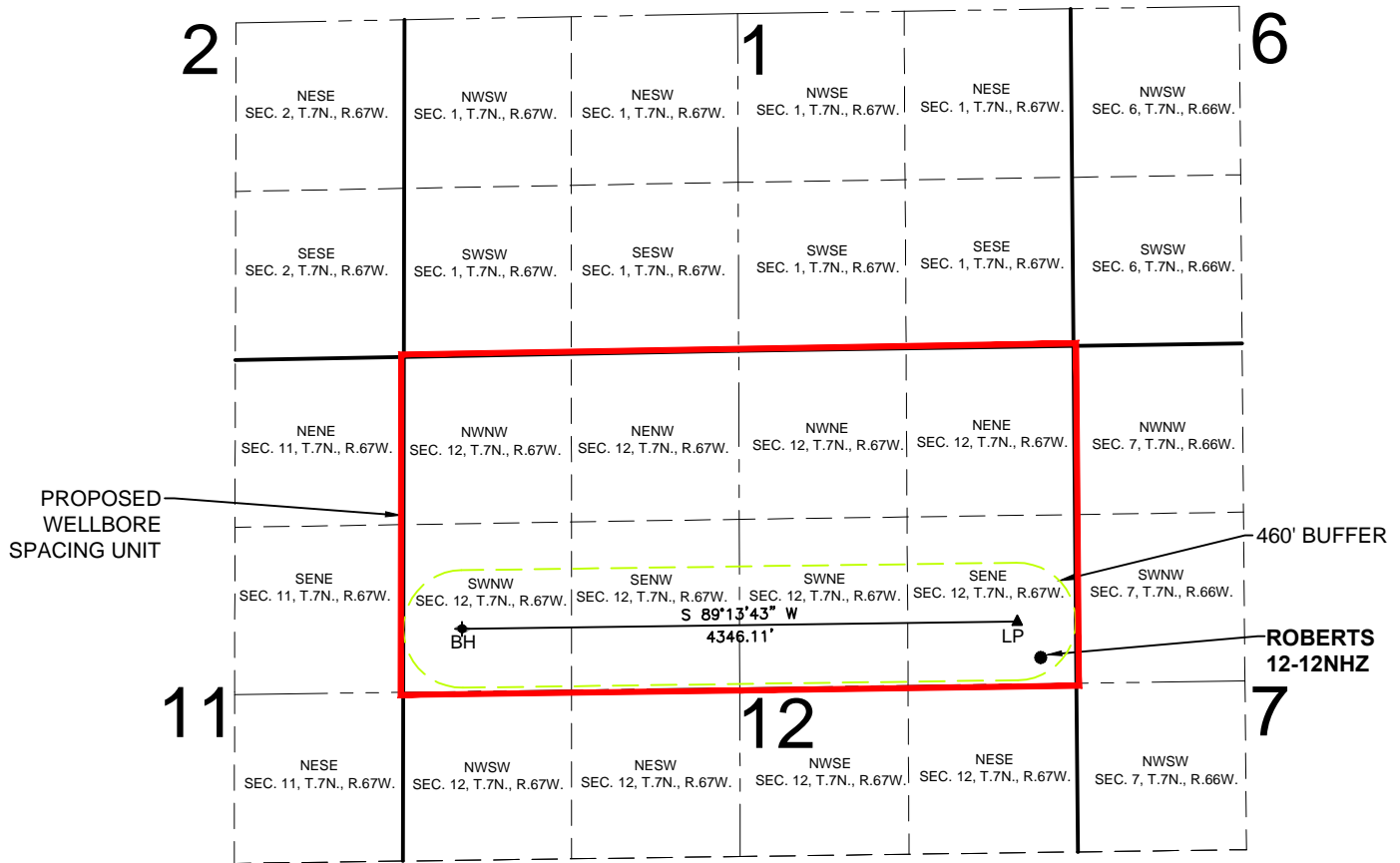

SURFACE LOCATION

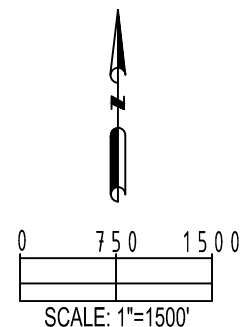
