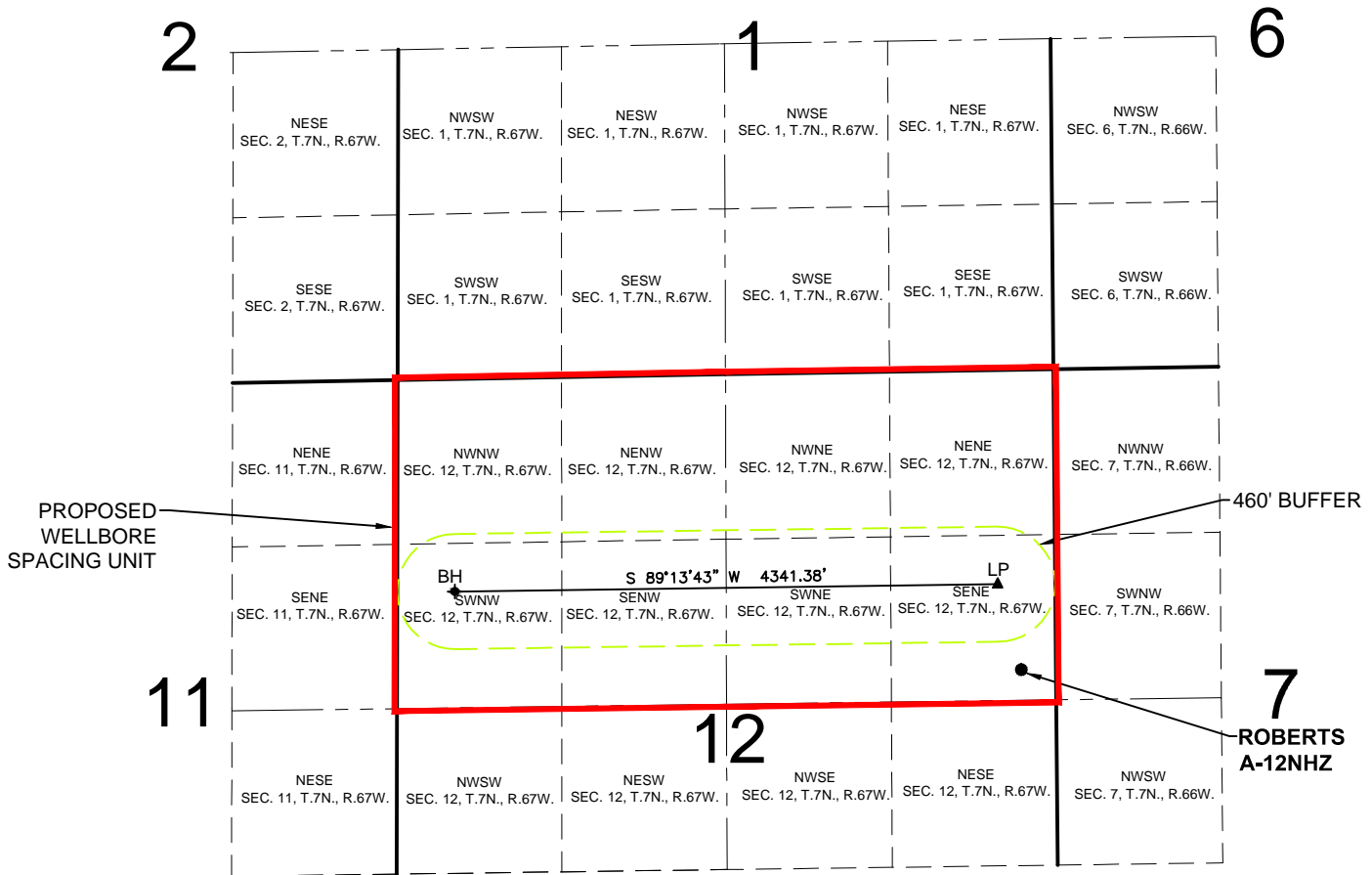

SURFACE LOCATION

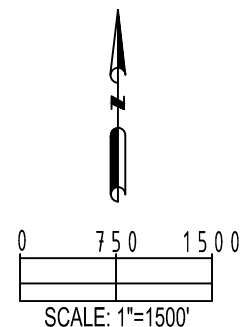
