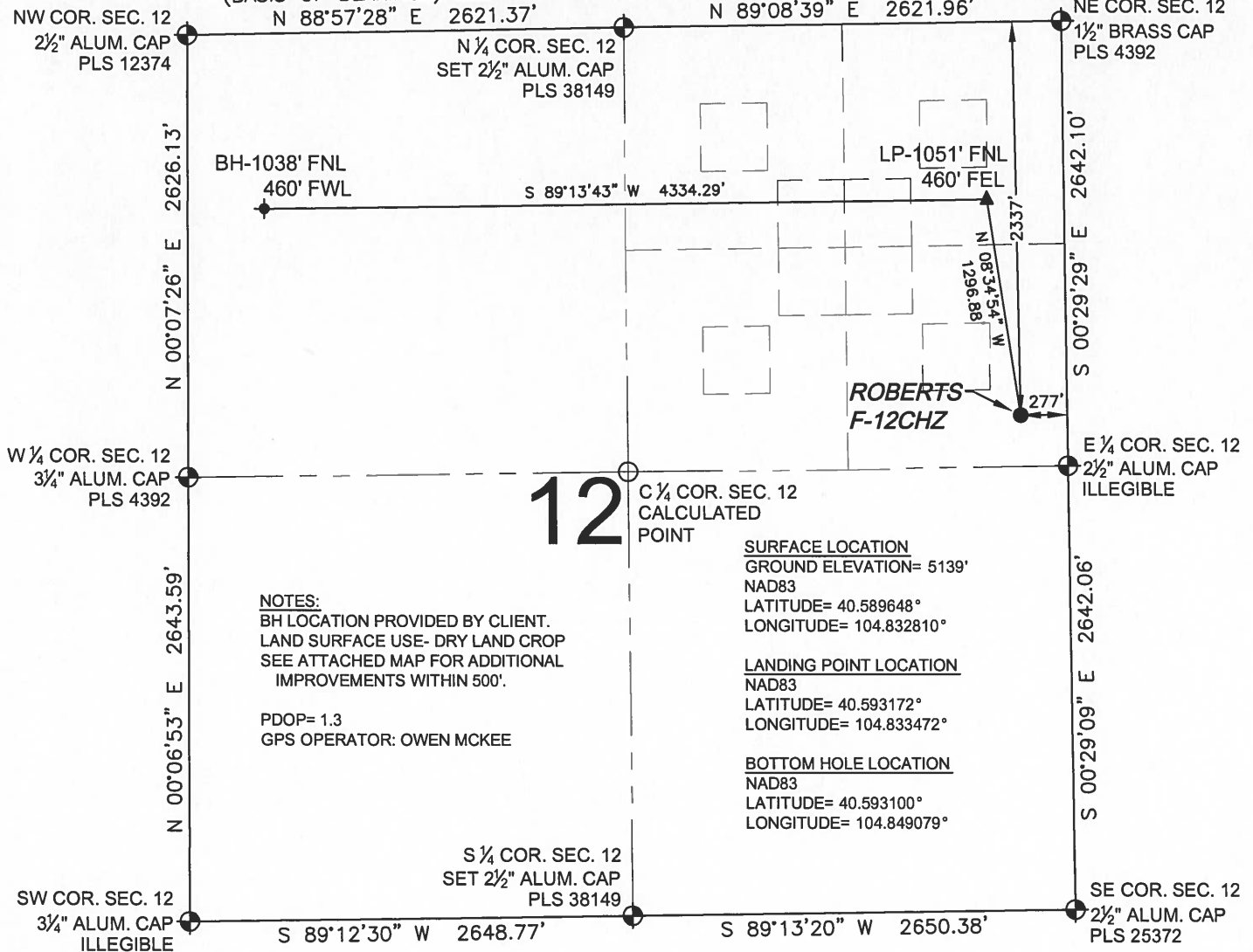


WELL LOCATION CERTIFICATE: ROBERTS F-12CHZ

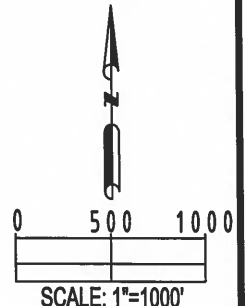
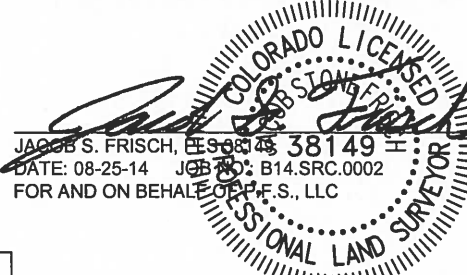
