David Kubeczko gave verbal permission on 02/05/2015 to allow Kinder Morgan to temporarily store drilling collars, closed loop half-round cutting bins, Weatherfords air package, and assorted misc. drilling equipment on location. Stormwater controls and weed control measures are in place. Kinder Morgan estimates that this equipment will be temporarily stored until September 2015 when the well is expected to be drilled.
