SWN cannot find any evidence of a CBL being run by the prior operator as required by permit condition. The Cement Job Report for the production casing is an attachment to this Sundry. Based off the attached cement report the calculated TOC is 934', assuming 10% excess. However, with the loss of returns during the cement job with 72 bbls of displacement pumped, the TOC could be as low as 2856'.

The production casing pressure is zero. The bradenhead pressure is 25#.

SWN does not have any immediate plans to complete the well, though a CBL will be run Spring 2015 when access to the location is available.
