Set a CIBP 50' above top perf and ran in with packer to pressure test casing and confirmed casing leak and found several casing holes, The bottom casing hole is at 2815'- to surface. Well has been temporarily abandoned. PDC Engineering evalutating plans to repair or plug the well.
