GWOG did a preconstruction reconnaissance visit with construction, operations and regulatory personnel to delineate pad location, layout, access, and any site specific mitigations that would be prudent. Based on this visit it was determined that sound mitigation efforts would be focused along the southern edge of the location and that no baseline noise survey was likely necessary. GWOG will install a 554-foot long, 32-foot high, fabric sound wall on the south edge of the pad for noise mitigation in the direction of a single residence to the south approximately 800 feet from the pad. There are additional residences farther south and south east of the pad. In addition, exhaust ports for engines on location will be directed away from the nearby residences to the south.
