

PROCEED IN A WESTERLY DIRECTION FROM HEREFORD COLORADO ALONG COUNTY ROAD #136 APPROXIMATELY 4.6 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD #71 TO THE NORTH; TURN RIGHT AND PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 0.5 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD #136.5 TO THE WEST; TURN LEFT AND PROCEED IN A WESTERLY, THEN SOUTHWESTERLY DIRECTION APPROXIMATELY 1.7 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE WEST; TURN RIGHT AND PROCEED IN A WESTERLY, THEN SOUTHWESTERLY DIRECTION APPROXIMATELY 1.3 MILES TO THE EXISTING LOCATION.

TOTAL DISTANCE FROM HEREFORD, COLORADO TO THE EXISTING LOCATION IS APPROXIMATELY 8.1 MILES

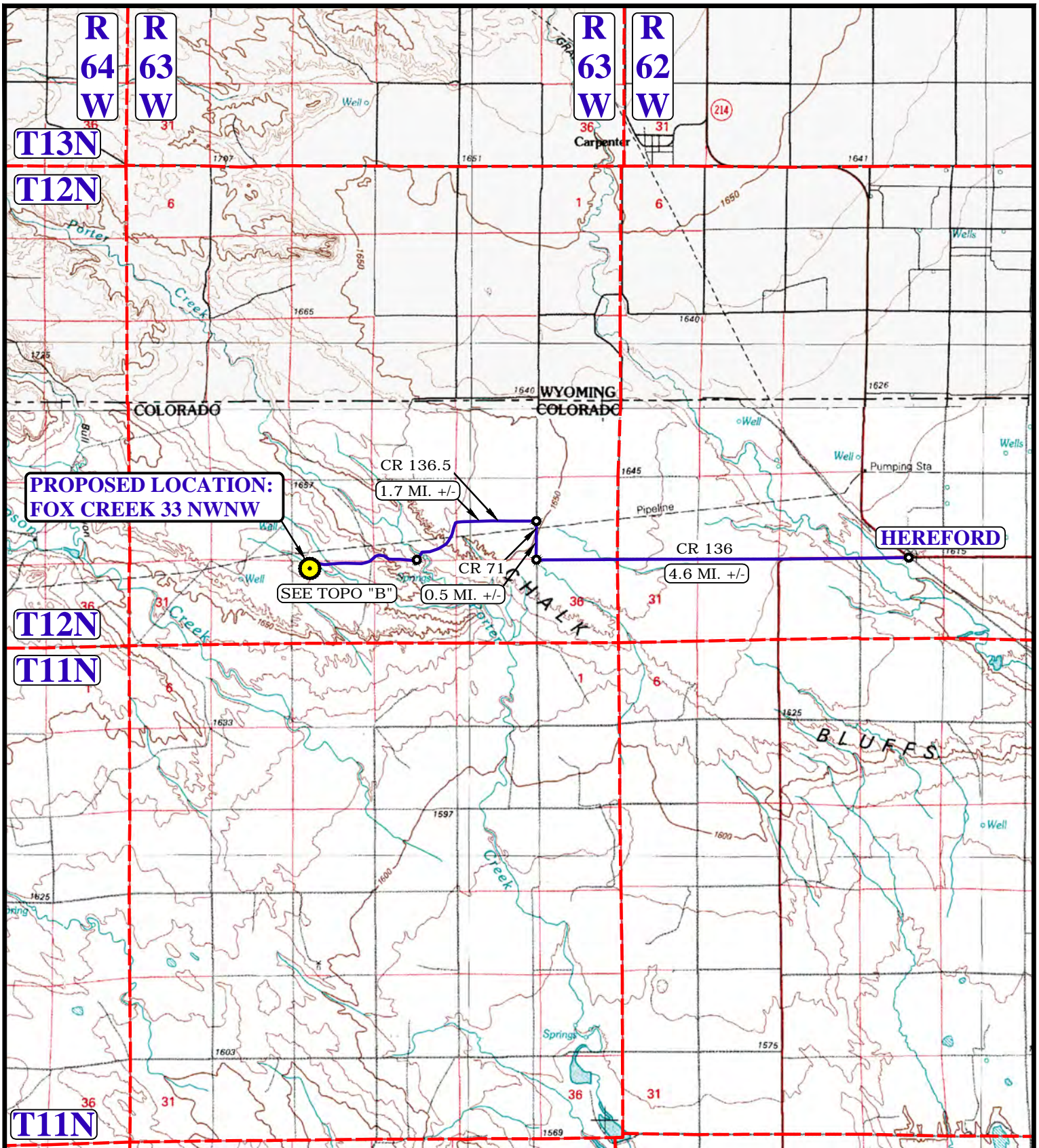

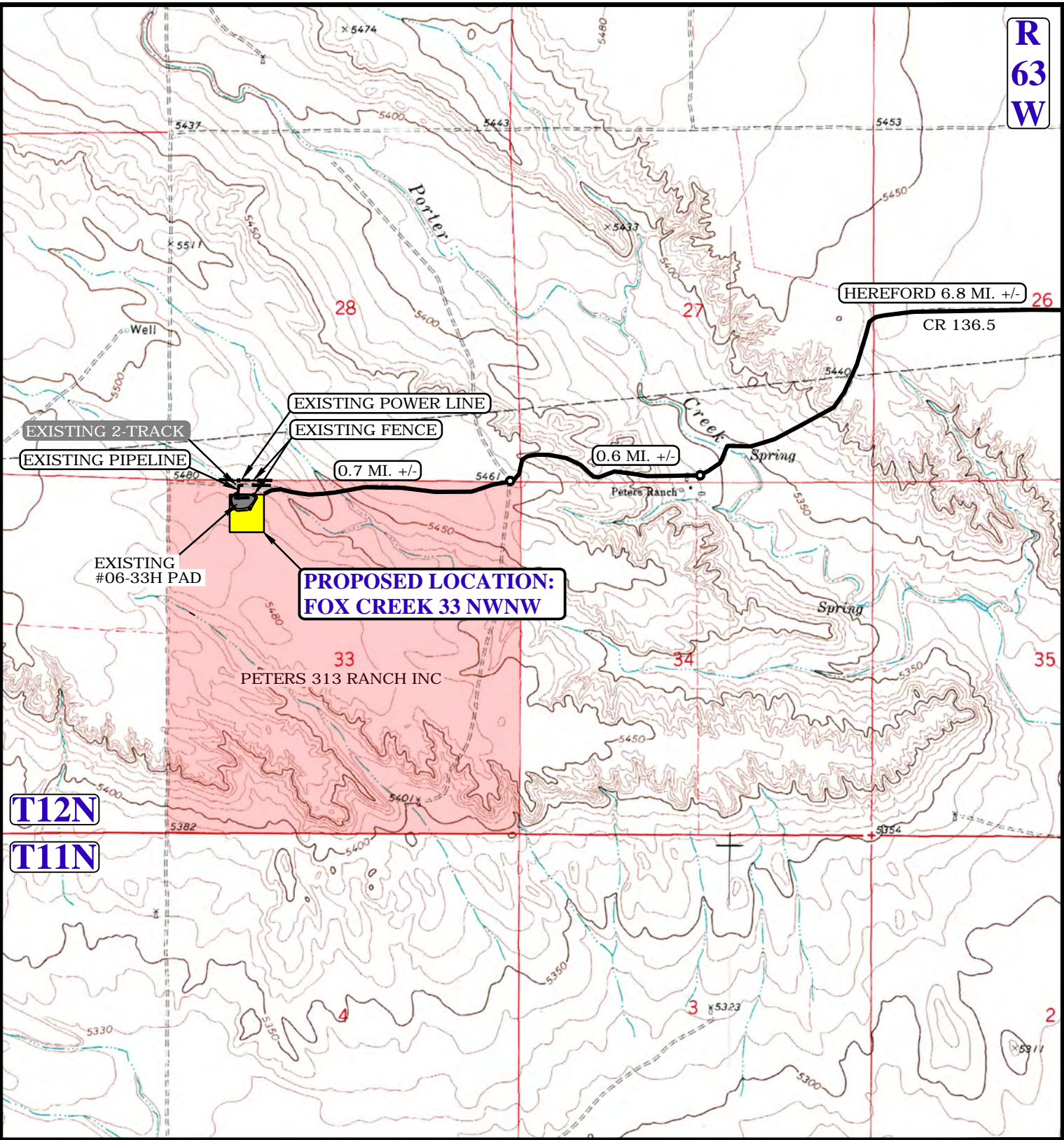
ACCESS ROAD MAP
