Dear Mr. Snyder:

Thank you for submitting a Notice of Intent to Construct a Non-Jurisdictional Dam (Notice). The Notice has been reviewed from both the perspectives of dam safety and water administration, and has been accepted. The signed Notice is being returned to you for your records. Electronic copies will be maintained in the Division 5 Office, and with the local Water Commissioner (Bruce Michealson).

This acceptance of the Notice of Intent form acknowledges that the dam is considered non-jurisdictional based on the information provided. Our acceptance of the notice does not convey a water right or authorization to store water. The pond cannot be filled when water is not legally available. An augmentation plan is required to fill the pond when the structure is out of priority, or if groundwater is encountered in the excavation.

Please notify the Water Commissioner, Bruce Michealson, in our office upon completion of the excavation of the pond so that he can inspect the pond prior to filling to ensure the general location, dimensions, and criteria included in the Notice have been met.

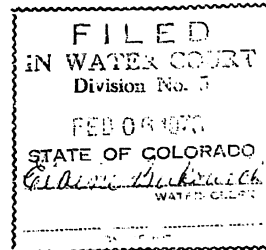

ABSOLUTE DECREE FOR
UNDER GROUND WATER RIGHTS

And the Referee having made the investigations required
by Article 21 of Chapter 148, C.R.S. 1963, as amended does hereby
make the following ruling, to wit:

This application was referred to the Water Referee of
Water Division No. 5 on the 12th day of July, 1972.

1. Name of Applicant Robert Arnold
Address R. R. 1, Box 94, Carbondale, Colorado
2. The name of the structure is Arnold Well.
3. The Legal description of the structure is: The well is located in Tract 63, Section 14, T. 8 S., R. 87 W. of the 6th P.M. at a point 937.12 feet East of the West line and 318 feet South of the North line of said Tract 63.
4. The depth of the well is 60 feet.
5. The date of initiation of appropriation is September 12, 1970.
6. The amount of water claimed is 0.088 cubic foot per second of time.
7. The use of the water is domestic and stock water.
8. The State Engineer's number is 42878.
9. The Priority date is September 12, 1970.
10. The date of the application was June 29, 1972.

It is the ruling of the Referee that the statements in the
application are true and that the above described water right is
approved and granted the indicated priority; subject, however, to
all earlier priority rights of others.

It is accordingly ordered that this ruling shall become
effective upon filing with the Water Clerk, subject to Judicial review
as provided by law.

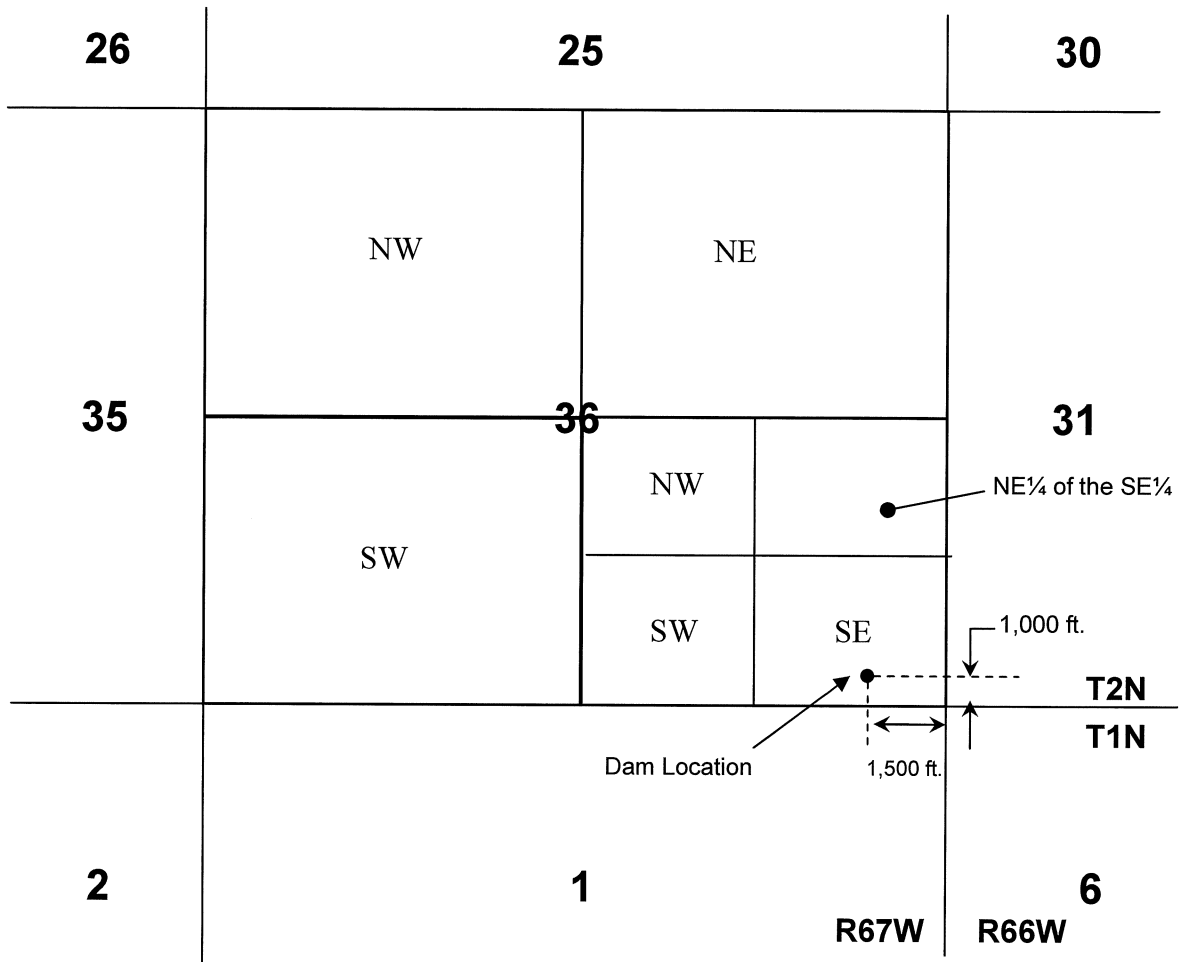
