This form has been prepared as a Notice of Intent to continue final reclamation on the Evacuation Creek 7612 well pad (322443) where due diligence sample collection identified the presence organic PAH constituents in soils beneath removed equipment at the site. The presence of these constituents resulted in a halt of the project until a site investigation was able to determine that these constituents were not the result of operation, but naturally occurring in the oil shale present at the site.
