Comments This is a re-file of the Parry GU #2. This well has been changed to a horizontal (Lateral 1) well with a horizontal sidetrack (Lateral 1 ST 1). This permit is for the Pilot Hole.

Please note that the waiver to the 30 day notice (Rule 305) and waiver to the consultation (Rule 306) can be found in the attached Surface Use Agreement.

A separate DPW letter has not been sent, the DPW notification is covered by the BP San Juan Basin Colorado Wildlife Mitigation Plan (MWP) dated March 2011.

BP may temporarily stage equipment associated with the drilling and completion of this well on other BP locations within the same spacing unit or lease to relieve congestion at the working site and improve safety without additional surface disturbance/expansion for this well.
