COMMENTS:

Great Western intends to flare gas for a short period of time to allow the well to clean up before going to sales. Once the well begins to cut hydrocarbons the test separator will be pressured up and all flow will be run through the test separator. All gas will be flared through a flare stack provided by the flowback vendor and once a sellable amount of gas is being made the gas will be run through our facilities to and through the sales meter. Facilities will be complete and functioning before this phase of the operation begins. The last gas analysis taken on 09/12/2014 shows less than 1 ppm of H2S. Please find the attached report.
