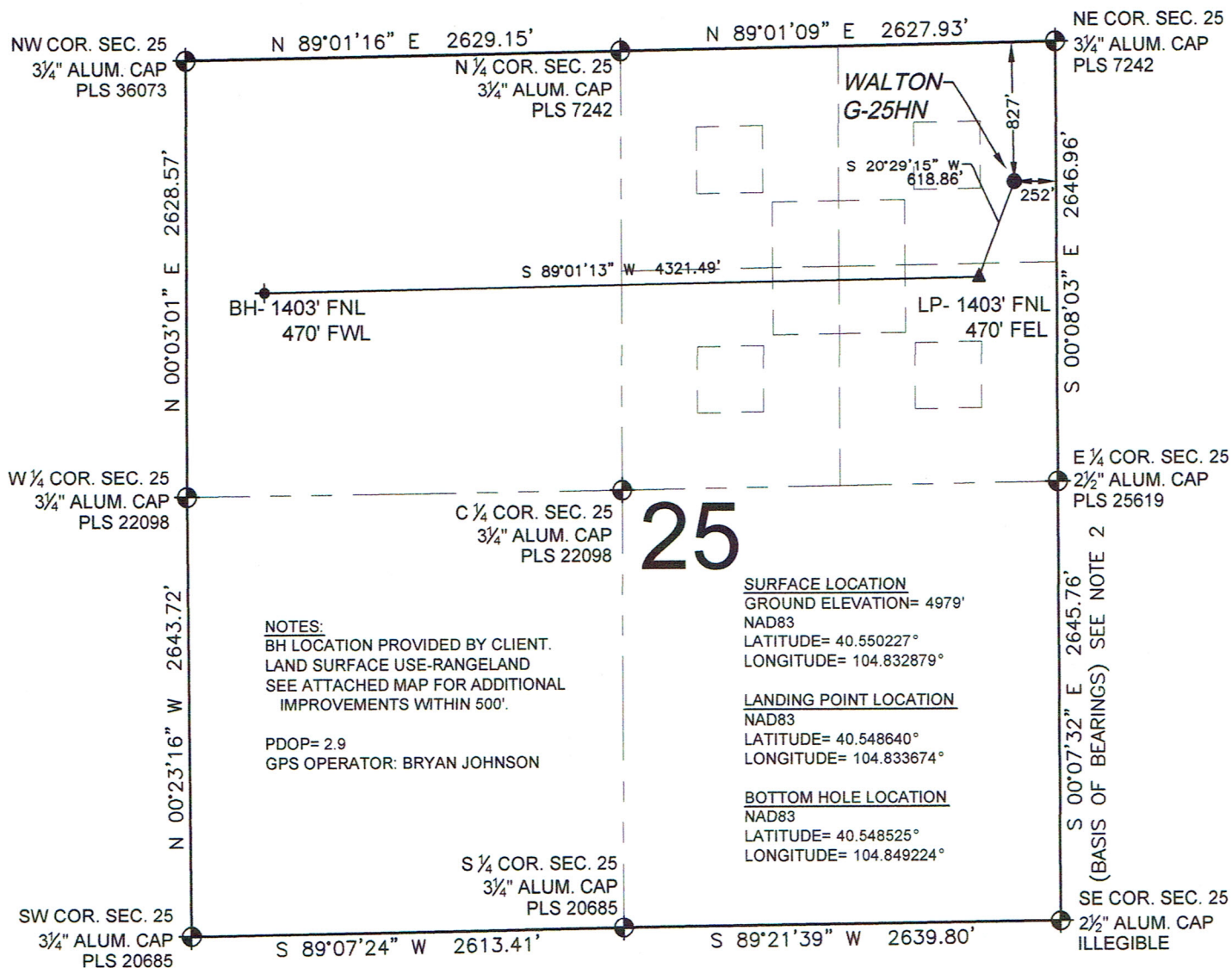


WELL LOCATION CERTIFICATE: WALTON G-25HN

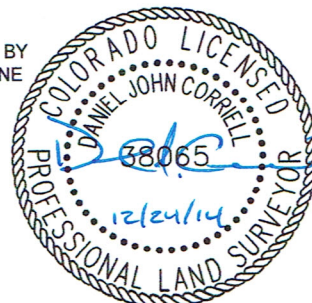
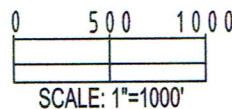
