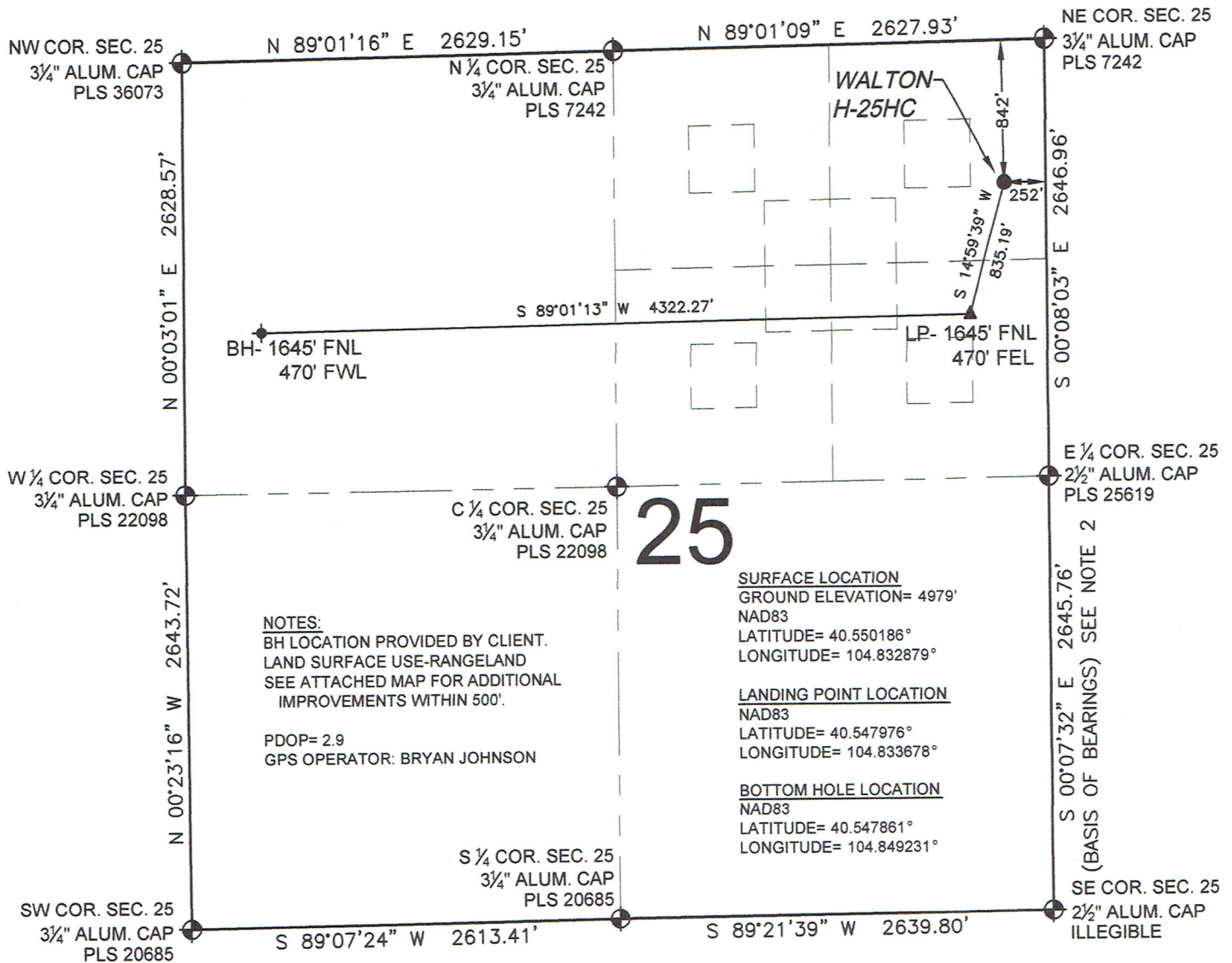


# WELL LOCATION CERTIFICATE: WALTON H-25HC

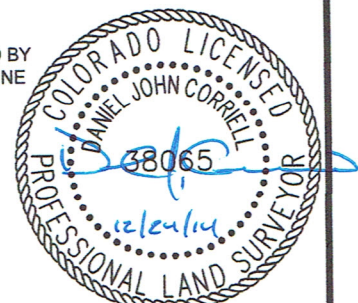
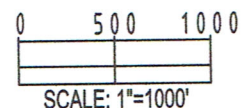
