I have completed my review of the referenced Form 2A Oil & Gas Location Assessment and have the following comment.

1) A review of the permit for the nearest water well (Permit #6100-AD) indicates the application was denied in 1976 and the water well was never constructed. The next nearest water well is Permit #49623 and is located greater than a mile from the proposed oil and gas location to the southeast. Therefore, I would like to change the distance to the nearest water well from 4,238 feet to 5,280 feet in the Water Resources section.
